



## FIELD PERCUSSION ADJUDICATION TRAINING PROGRAM 2010

### REQUIREMENTS:

1. Attendance at the SCSBOA Field Training Seminar to be held Saturday August 14 at Aliso Niguel HS (time will be 9 – 10:30 a.m.) or attend a shortened version of this session at the SCSBOA Fall Conference Saturday September 11, 2010 (time TBA).
2. Provide information regarding your judging experience for SCSBOA or other organizations and/or experience working with percussion groups.
3. SCSBOA membership must be current prior to first assignment.
4. Submit the Field Percussion Application Form

### CRITERIA FOR EVALUATION OF APPLICANT'S QUALIFICATIONS:

1. Has the candidate been involved with a quality performing organization; does the candidate have prior judging experience; would the candidate have the ability to evaluate colleagues' groups objectively; would the candidate demonstrate confidence in his/her decision-making ability; and would the candidate be accepted and respected by the membership?

### KNOWLEDGE OF PERCUSSION SHEET:

1. Attendance at one the scheduled training sessions is essential. At these sessions the candidate will receive training in the following: definition of terms; criteria reference for each caption; procedures and techniques for digital recording judging; and procedures and techniques for completion of the adjudication form.
2. Prior to his/her first event, the adjudicator must review this training to be familiar with the REVISED field percussion sheet and criteria references.

### EVALUATION BY FIELD ADJUDICATION STEERING COMMITTEE/RECOMMENDATION TO THE SCSBOA BOARD OF DIRECTORS:

1. The FASC will review the criteria and application data and if all requirements are met, will recommend that the candidate be certified by the SCSBOA Board of Directors as a Probationary Percussion Adjudicator.
2. Probationary Percussion Adjudicators may be evaluated during fall assignments.
